# Florida Walgreens Opioid Litigation Documents – Red Flags for Diversion

**Summary**: Walgreens filled opioid prescriptions in Florida under circumstances showing red flags for opioid diversion, i.e. prescription opioids obtained or used illegally. Suspicious orders at Walgreens distribution centers and retail pharmacies should have warranted further investigation and due diligence.
