**ORDER (I) APPROVING THE UNIVERSITY OF CALIFORNIA,
SAN FRANCISCO FOUNDATION AND JOHNS HOPKINS UNIVERSITY
AS THE PUBLIC DOCUMENT REPOSITORY UNDER VOLUNTARY
INJUNCTION AND (II) AUTHORIZING DEBTORS TO PAY THEIR ALLOCABLE
SHARE OF REASONABLE COSTS AND EXPENSES RELATED THERETO**

Upon the *Joint Motion of Debtors and Governmental Plaintiff Ad Hoc Committee for Entry of an Order (I) Approving the University of California, San Francisco Foundation and Johns Hopkins University as the Public Document Repository Under Voluntary Injunction and (II) Authorizing Debtors to Pay Their Allocable Share of Reasonable Costs and Expenses Related Thereto* (the “**Motion**”);² and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated February 29, 2012; and consideration of the Motion and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and the Debtors consent to entry of a final order by this Court under Article III of the United States Constitution; and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and appropriate notice of and the opportunity for a hearing on the Motion having been given; and the relief requested in the



Motion being in the best interests of the Debtors' estates, their creditors and other parties in interest and having been negotiated and approved by the Settling States; and the Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Motion is GRANTED to the extent set forth herein.
2. The State of Minnesota, on behalf of itself and all of the other Settling States, is hereby authorized, but not directed, to engage the University of California, San Francisco Foundation and Johns Hopkins University to host the Public Document Repository of the Section V Documents pursuant to Section V.E.1 of the Voluntary Injunction.
3. The VI-Specific Debtors are authorized to pay to the University of California, San Francisco Foundation and Johns Hopkins, collectively, in their capacity as host of the Public Document Repository, the aggregate total of \$2.75 million, which amount is the entire sum of the VI-Specific Debtors' allocable share of all reasonable costs and expenses associated with the public disclosure and storage of the Section V Documents, in accordance with the terms and conditions of the Voluntary Injunction, the MLOU, and this Order.
4. The contents of the Motion and the notice procedures set forth therein are good and sufficient notice and satisfy the Bankruptcy Rules and the Local Rules, and no other or further notice of the Motion or the entry of this Order shall be required.
5. Notwithstanding Bankruptcy Rule 6004(h), the terms and conditions of this Order are immediately effective and enforceable upon its entry.
6. The Debtors are authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion.

7. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order during the pendency of the Debtors' chapter 11 cases.
